Governance Group

Strategic Plan

Over three sessions in 2023 the Governance Group went through a process of designing a new strategic Plan. The Strategic Plan will commence in July and be a five-year plan, with annual action plans.

Participation in the Strategic Planning session, included consultations with practitioners, community and partners.

Advocacy

The Gippsland Family Violence Alliance developed an <u>election campaign</u>, aimed at the Federal Government around Workforce Capacity and Gippsland's specific needs. This document went live in October and has since been utalised by the Centre of Workforce Excellence in DFFH to better understand the workforce needs in regional/rural areas.

MARAM Collaborative Practice

MARAM Collaborative Practice has been delivered throughout the 2022-2023 period online. In late 2023, the GFVA re-worked the training package to include the updated FSV resources, including videos, stronger links to our Gippsland resources such as our website and adding a case study which includes culturally specific elements for our Aboriginal Communities, with several more case studies in development.

MARAM Collaborative Practice is funded by Family Safety Victoria, but is the responsibility of the Gippsland Family Violence Alliance to deliver locally. The training can be ran in person or online and Gippsland has the highest targets in the state to deliver.

Strategic Priority: Workforce Capacity and Capability

Practice and Connection Forums

Practice and Connection Forums grew out of the recognition that a one day MARAM Collaborative Practice Training is not enough for practitioners to learn about the wider service system, which is what drives collaborative practice.

So the aim of the Practice and Connections Forums are to build skill, knowledge and collaborative practice. The sessions are aligned to assist practitioners to understand how to use the MARAM Framework in practice and to apply an intersectional lens, which includes challenging their own bias, preconceived ideas and conceptions. We encourage practitioners to learn from one another, share information and build relationships outside the Forums.

The sessions are run in Inner Outer Gippsland, in acknowledgement of the way our service systems operate and the manner in which our practitioners need to collaborate with one another.

While each Forum is based around a topic, we try to ensure that MARAM and intersectional practice is still centered throughout.



This is the first year we have run these sessions, and our knowledge and skill around these sessions will grow with time.



Human Trafficking

We had Christine Carolan the National Executive Officer with ACRATH and members from the Federal Police talk to Practitioners about working with those who are victims of trafficking or who they suspect might be trafficked.

Safety Planning with Victim Survivors

This session was a deep dive into Safety Planning. We looked at the Safety Plan templates that are in the Intermediate and Comprehensive responsibilities in MARAM and looked at how to create a detailed plan with a victim survivor based on their individual circumstances.

Technology-Facilitated Abuse in Domestic and Family Violence Situations

We had the E-Safety Commissioner come to Gippsland to give practitioners information on technology related abuse. They also provided resources, links to useful information and tips for frontline workers.

Risk factors specific to Particular Cohorts of Victim Survivors

This was an online session, designed to build upon the Safety Planning session that had occurred in February. The purpose was to do a deep dive on how to apply safety planning to specific cohorts who may have intersectional oppressions, which cause specific needs within their safety planning.

Men's Behaviour Change and Caring Dad's Program Explained

We had presenters from Latrobe Community Health, The Salvation Army and Anglicare, talk to practitioners about their programs, but also how they work with men using a person-centered approach. How to talk to men about referrals, the role of family contact workers, how information sharing is used and the criteria for the program was discussed at length to generate discussion and questions.

Strategic Priority: Workforce Capacity and Capability

Communities of Practice

Communities of Practice originally began in Gippsland to bring together workforces who were experiencing isolation. We also try to create an environment where they share knowledge and create networks outside of the group.





Gippsland Behaviour Change Community of Practice

Due to capacity constraints, this group has only met three times in the 2022-2023 period, however it is meeting every two months going forward.

The group consists of both practitioners who work with men using violence and those who work with adolescents using violence. Recently the decision was made to break into small groups to have discussions around course content and to explore how different agencies are engaging clients.



Supervisors Community of Practice

The Supervisors Community of Practice was facilitated by Jane Wexler and ran for the 2022 period and met 5 times in 2022-2023 period. There were 20 people accepted into the CoP, but due to staff turn over and duplication with the Graduate Program Community of Practice, we only had 14 people complete the sessions, with 7 regularly attending.



Due to the similarities with the Graduate Program Community of Practice facilitated by Family Safety Victoria, the Governance Group made the decision not to continue resourcing this CoP.



Strategic Priority: Effective cross-sector governance for system leadership

Communication historically hasn't been a focus for regional integration committees. However, investing in purposeful communication strategies can facilitate collaboration, and decision making, boost brand recognition and provide legitimacy around advocacy efforts, and build stronger relationships with partners. As such, we have contracted a Communication Coordinator, one day a week, to assist us and create and implement a Communication Strategy.

New Branding

With the redesign of the website, it was realised that we needed some additional colors in our branding to create variation and depth. As such 4 additional colors were added to the branding as secondary colors.

Stop Card Redesign

The STOP Family Violence Cards have been a mainstay since the 1990's. However, it had become clear that with the increasing number of phone numbers on them that it was confusing for those in the community to navigate. While the new design hasn't been fully finalised, a body of work has been undertaken to create a card that is both educational and easy to navigate for community members. Final rounds of consultation will occur in July/August 2023.

Document Design and Creation

As part of redeveloping the website, we have turned our Communities in Focus Newsletters into downloadable resources that practitioners can access.

These resources were developed prior to the 2022-2023 period, but were redesigned and updated as a result of the website. They were written either in consultation with practitioners from across the sector, or have been written by partners within the GFVA. They outline how to work with specific communities, including:

- Mental Illness and Family Violence
- Elder Abuse
- Substance use coercion as a barrier to safety and recovery
- Intellectual Disability and family violence
- Reproductive coercion
- Mis-identification and family violence

One new document was created for the sector, which was developed as a result of the Practice and Connection Forums which was:

• Safety Planning with victim-survivors

Which was designed to give practitioners and understanding of how to build upon the MARAM Safety Plan.

Motel Coordination Project

The Motel Cordination Project which was auspiced by Gippsland Family Violence Alliance, Inner Gippsland and Gippsland Lakes Complete Health in Outer Gippsland has provided us with a snapshot of the key issues facing agencies and their service users when accessing motels.

Lived Experienced Journey Mapping

In October 2022, Deakin University was engaged to complete Journey Mapping of clients who have experienced family violence in the past 2 years in Gippsland. They will also interview 10 practitioners. Ethics approval was a lengthy process and was delayed because of concerns of bringing up traumatic memories with those who had experienced violence. Ethics approval was achieved in late April and the team at Deakin and GFVA have been working with agencies to start engaging those who have used services.

Djirra Sisters Day

To encourage participation in the Journey mapping, GFVA team members attended the Djirra sisters day and ran an activity where people could share what made them proud and one thing that needs to change on canvas's.

The responses varied greatly on age and were very affirmative.

SFVIAC Specialist Family Violence Integration Advisory Committee

SFVIAC is the statewide group of 13 PSA's which come together monthly to meet to discuss key issues, participate in consultations with stakeholders and work towards strategic priorities. We also meet bimonthly with FSV. SFVIAC receive modest funding. Currently we are working on a Theory of Change and updating our Stakeholder Engagement Plan.
